

Privacy Statement

At Henry Schein, Inc., your privacy is important to us. The following statement describes the privacy practices we use on our Web site. COLLECTION AND USE OF INFORMATION

Henry Schein collects information volunteered by the visitor in registering or participating in surveys, such as your name, address, telephone number, and practice name. In addition to the information you volunteer, our web server automatically collects such information as the domain name of the site providing you with Internet access, the Internet protocol (IP) address used to connect your computer to the Internet, your browser type and version, operating system and platform, the average time spent on our site, pages viewed, information searched for, access times and other relevant statistics.
